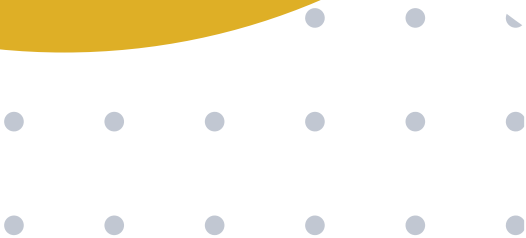

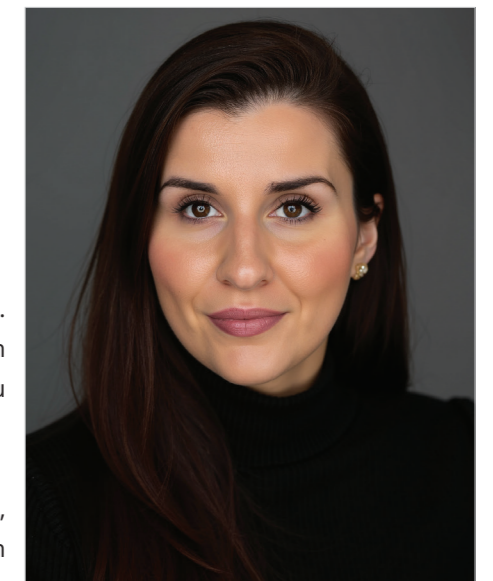

Delivery Modes

Students participate in on-campus learning supported by online activities through our Learning Management System (MOODLE), providing a flexible and interactive educational experience.

Protection of fee paid in advance

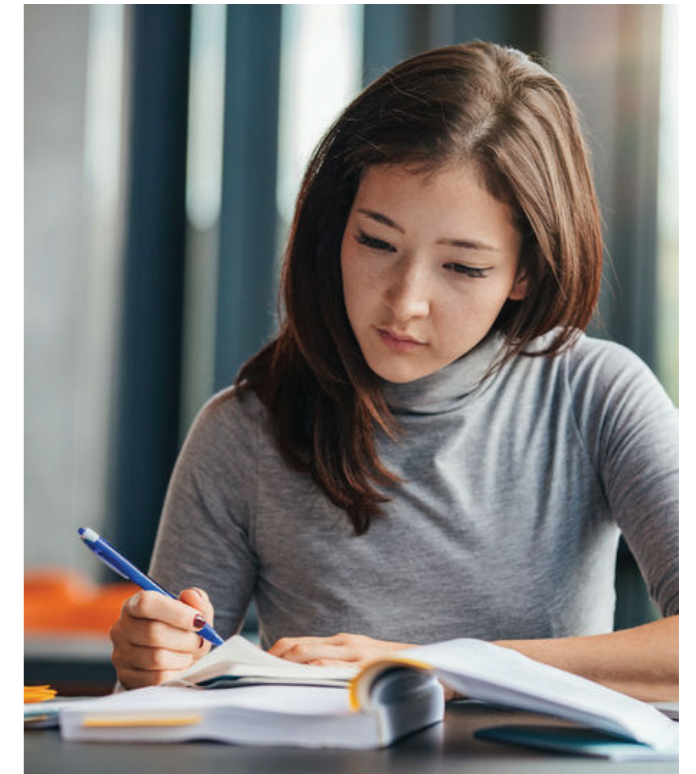
Tuition fee paid in advance by student is protected under commonwealth's Tuition Protection Service (TPS). TPS is a placement and refund service for international students. The TPS is like an insurance cover for fees paid in advance. It is a single mechanism to place students when a provider fails to meet obligations or as a last resort to provide refunds of unexpended prepaid tuition fees.

RPL and Exemptions

RPL and credit transfer can be applied for at the time of enrolment or during the orientation. Students may be eligible to obtain credits for individual units as a result of experience gained in the relevant field or from previous training and education. A Fee is payable for assessing your RPL status. The information is available online in the student handbook or can be requested at the reception.

Training and Other Facilities

CIBT trains and assesses its students from its campuses in Sydney CBD, North Sydney, Hurstville and Canberra which are fully equipped with required facilities including modern computer labs with internet access, data projectors & resources borrowing facility, printing & photocopy facility and a student common area.



Articulation & Pathways

Under the principles of mutual recognition, qualifications and Statements of Attainment issued by CIBT are recognised by other Registered Training Organisations (RTOs) across Australia. Upon successful completion of a vocational qualification, students may be eligible for credit or exemption in related courses. Graduates can also explore pathway opportunities into higher education qualifications.



Certificate IV in Accounting and Bookkeeping

National Course Code: FNS40222 | CRICOS Course Code: 109976E | Duration: 52 weeks

Course Description

This qualification reflects the role of individuals in the accounting and bookkeeping industry, including business activity statement (BAS) agents and contract bookkeepers; and of those employees performing bookkeeping tasks for organisations in a range of industries. It includes preparing and lodging business and instalment activity statements, data processing, monthly reconciliations, preparing budgets, preparing reports on financial performance and the position of the business, preparing end-of-year adjustments, and finalising financial records after year-end. Dealing with the Commissioner of Taxation on behalf of a taxpayer in relation to activity statements and other lodgement matters is also a key component of the role that this qualification reflects. Individuals in these roles apply theoretical and specialist skills and knowledge to work autonomously, and exercise judgement in completing routine and non-routine activities.

Entry Requirements

The course will be available for those students who completed year 12 or equivalent. International students require a minimum English level of IELTS 6.0 (with no individual band less than 5.5) If the level of English is insufficient, a suitable course can be organised.

Vocational Outcomes

Graduates of this qualification should be able to work in various accounting job roles with duties such as completing Business Activity Statements (BAS) and lodging taxes, operational reporting, producing non-complex management reports including compiling budget information, compiling data for job costing reports, supervising the operation of computer-based financial systems, classifying, recording and reporting accounting information, maintaining inventory records, managing a small office, ensuring relevant legal requirements

are adhered. Job roles may include Accounts Receivable and Payable Clerks, Payroll clerks, Bookkeepers, General Clerical Assistants & Trainee Accountants.

Target Group

The target group for the FNS40222 Certificate IV in Accounting and Bookkeeping is people who have an interest in the accounting and book-keeping aspect of the financial services industry and would like to commence their career in accounting sector. The program is designed for local and international students wishing to develop their existing accounting skills and to those who are already working in the industry and wish to obtain the qualification to broaden their knowledge, skills and career prospects or wish to articulate to FNS50217 Diploma of Accounting. International students will come from a range of countries spanning Asia, Eastern Europe and the Middle East. Many international students have industry experience and wish to receive an Australian qualification.

Delivery Modes

CIBT uses a blended learning methodology combining classroom-based learning with computer-mediated activities as studies show blended learning improves student's interaction and satisfaction as well as increase learning outcomes. Delivery involves 20 hours per week total tuition with 13.5 hours/week of classroom-based delivery on campus and for 6.5 hours/week students would be taking part in computer-mediated activities via online Learning Management System (MOODLE).

Course Completion

Students obtaining a 'Competent' result for all the units in this qualification will achieve Certificate IV in Accounting and Bookkeeping. A statement of attainment will be issued only for the units in which a student has been found 'Competent'.

Trainers and Assessors

All CIBT trainers/assessors are highly qualified and experienced. They have TAE40116 Certificate IV in Training and Assessment or its equivalent plus suitable industry experience along with the qualification to teach Certificate IV in Accounting and BookkeepingAsia, Eastern Europe and the Middle East. Each unit will be assessed in at least 2 different ways unless otherwise required by the unit of competency. The assessment will be conducted through take home research, assignments, projects, case studies, demonstrations and presentation.

The 13 units of competency (10 Core and 3 Electives) are delivered throughout the 52 Weeks (36 weeks tuition and 16 weeks holiday). All units of competency must be completed to receive a Certificate IV in Accounting and Bookkeeping qualification.

Diploma of Accounting

National Course Code: FNS50222 | CRICOS Course Code: 111544M | Duration: 65 weeks

Course Description

This qualification reflects accounting job roles in financial services and other industries, including tax agents, accounts payable and accounts receivable officers, payroll service providers, and employees performing a range of accounting tasks for organisations in a range of industries. Individuals in these roles apply solutions to a range of often complex problems and analyse and evaluate information from a variety of sources. They apply initiative to plan, coordinate and evaluate their own work and provide guidance to others within defined guidelines.

Entry Requirements

The course will be available for those students who completed year 12 or equivalent. International students require a minimum English level of IELTS 6.0 (with no individual band less than 5.5) If the level of English is insufficient, a suitable course can be organised.

Prior to commencing this qualification an individual must have completed the following units of competency (or equivalent):

- FNSACC321 Process financial transactions and extract interim reports
- FNSACC322 Administer subsidiary accounts and ledgers
- FNSACC418 Work effectively in the accounting and bookkeeping industry
- FNSACC421 Prepare financial reports (this unit is the equivalent version of BSBFIA401 Prepare financial reports).

These competencies may have been achieved through completion of the following (or their equivalent):

- FNSSS00014 Accounting Principles Skill Set, or
- FNS40222 Certificate IV in Accounting and Bookkeeping.

Vocational Outcomes

The primary pathway from this qualification is employment in accounting job roles with duties such as introducing and maintaining accounting systems, maintaining internal control systems, preparing financial statements for a non-reporting entity, preparing tax returns, reporting on business performance & preparing accounting reports for management. Job roles may vary across the various sectors, but may include Accountants, Senior Financial Clerks & Account managers.

Target Group

The target group for the FNS50222 Diploma of Accounting is local and international students wishing to develop their existing accounting skills and to those who are already working in the industry and wish to obtain the qualification to broaden their knowledge, skills and career prospects or wish to articulate to FNS60217 Advanced Diploma of Accounting. The course provides a solid overview of financial sector with an operational knowledge in general accounting and related areas. International students will come from a range of countries spanning Asia, Eastern Europe and the Middle East. Many international students have industry experience and wish to receive an Australian qualification.

Delivery Modes

CIBT uses a blended learning methodology combining classroom-based learning with computer-mediated activities as studies show blended learning improves student's interaction and satisfaction as well as increase learning outcomes. Delivery involves 20 hours per week total tuition with 13.5 hours/week of classroom-based delivery on campus and for 6.5 hours/week students would be taking part in computer-mediated activities via online MOODLE Learning Management System (MOODLE).

Course Completion

Students obtaining a 'Competent' result for all the units in this qualification will achieve Diploma of Accounting. A statement of attainment will be issued only for the units in which a student has been found 'Competent'.

Advanced Diploma of Accounting

National Course Code: FNS60222 | CRICOS Course Code: 111545K | Duration: 78 weeks

Course Description

This qualification reflects the role of individuals working in accounting and seeking professional recognition, including tax agents, accounts managers and business analysts; and to employees performing a range of accounts management tasks for organisations in a range of industries. At this level individuals are expected to apply theoretical and technical skills in a range of situations and to display initiative and judgement in planning activities. They have autonomy in performing complex operations and can be responsible for planning, coordinating and evaluating the work of others within broad parameters.

Entry Requirements

The course will be available for those students who completed year 12 or equivalent. International students require a minimum English level of IELTS 6.0 (with no individual band less than 5.5) If the level of English is insufficient, a suitable course can be organised.

Prior to commencing this qualification an individual must have completed the following qualifications (or equivalent):
 FNS50222 Diploma of Accounting; or its superseded version
 FNS50217 Diploma of Accounting or equivalent, provided the listed elective unit BSBTEC402 Design and produce complex spreadsheets (or equivalent) has been completed by those seeking to enrol.

Vocational Outcomes

Graduates with proper employability skills should be able

to work as an Accountant, Financial Accounting Officer and Costing Project Manager.

Target Group

The target group for this qualification includes candidates who wish to upgrade their Diploma of Accounting so they can ascend their career ladder as an Accountant, and/or progress to bachelor's degree. Students can build strong foundation in accounting and learn about financial management, auditing, management accounting, and taxation. This may include local and international student with Diploma of Accounting or equivalent qualification with some vocational experience.

Course Completion

Students obtaining a 'Competent' result for all the units in this qualification will achieve Advanced Diploma of Accounting. A statement of attainment will be issued only for the units in which a student has been found 'Competent'.

Trainers and Assessors

All CIBT trainers/assessors are highly qualified and experienced. They have TAE40116 Certificate IV in Training and Assessment or its equivalent plus suitable industry experience along with the qualification to teach Advanced Diploma of Accounting.

Assessments

Each unit will be assessed in at least 2 different ways unless otherwise required by the unit of competency. The assessment will be conducted through take home research, assignments, projects, case studies, demonstrations and presentation.

Course Structure

The 14 units of competency (3 Core and 11 Electives) are delivered throughout the 78 Weeks (54 weeks tuition and 24 weeks holiday). All units of competency must be completed to receive an Advanced Diploma of Accounting qualification.

Certificate III in Early Childhood Education and Care

National Course Code: CHC30121 | **CRICOS Course Code:** 116563A | **Duration:** 52 weeks | **Work Placement:** 162 hours

Course Description

This qualification reflects the role of educators in early childhood education and care who work in regulated children's education and care services in Australia. They support children's wellbeing, and development in the context of an approved learning framework. Educators use a range of well-developed skills and knowledge using discretion and judgment when carrying out their work in the context of established policies and procedures. They may work independently or under the guidance of others, though in some contexts that guidance may not be on-site.

Early childhood educators work in long day care centres, family day care, pre-schools or kindergartens.

To achieve this qualification, the individual must have completed a total of least 162 hours of work in a regulated children's education and care service in Australia as detailed in the Assessment Requirements of units of competency. The total number of hours may be applied collectively across all units of competency that include the requirement for workplace hours.

Entry Requirements

The course will be available for those students who completed year 12 or equivalent. International students require a minimum English level of IELTS 6.0 (with no individual band less than 5.5) If the level of English is insufficient, a suitable course can be organised.

Vocational Outcomes

This qualification reflects the role of educators in early childhood education and care who work in regulated children's education and care services in Australia. They support children's wellbeing, and development in the context of an approved learning framework. Educators use a range of well-developed

skills and knowledge using discretion and judgement when carrying out their work in the context of established policies and procedures. Job roles and titles vary across different industry sectors. Possible job titles relevant to this qualification are:

- Assistant room leader

Target Group

The target group for CHC30121 Certificate III in Early Childhood Education & Care is people who have an interest in the Early Childhood Education Sector and in particular in having the desire to develop employment skills within the Childcare Industry.

Delivery Modes

CIBT uses a blended learning methodology combining classroom-based learning with computer-mediated activities as studies show blended learning improves student's interaction and satisfaction as well as increase learning outcomes. Delivery involves 20 hours per week total tuition with 16 hours/week of classroom-based delivery on campus and for 4 hours/week students would be taking part in computer-mediated activities via online Learning Management System (MOODLE). During the course, students will engage in 162 hours of work placement in a licensed early childhood setting.

Course Completion

Students obtaining a 'Competent' result for all the units in this qualification will achieve Certificate III in Early Childhood Education & Care. A statement of attainment will be issued only for the units in which a student has been found 'Competent'.

Trainers and Assessors

All CIBT trainers/assessors are highly qualified and experienced. They have TAE40116 Certificate IV in Training and Assessment or its equivalent plus suitable industry experience along with the qualification to teach Certificate III in Early Childhood Education & Care.

Assessments

Each unit will be assessed in at least 2 different ways unless otherwise required by the unit of competency. The assessment will be conducted through take home research, assignments, projects, case studies, demonstrations and presentation.

Course Structure

Diploma of Early Childhood Education and Care

National Course Code: CHC50121 | **CRICOS Course Code:** 116564M | **Duration:** 52 weeks | **Work Placement:** 288 hours

Course Description

This qualification reflects the role of educators in early childhood education and care who work in regulated children's education and care services in Australia. Educators at this level are responsible for designing and implementing curriculum that meets the requirements of an approved learning framework and for maintaining compliance in other areas of service operations.

Early childhood educators work in long day care centres, family day care, preschools or kindergartens. To achieve this qualification, the individual must have completed a total of least 288 hours of work in a regulated children's education and care service in Australia as detailed in the Assessment Requirements of units of competency. The total number of hours may be applied collectively across all units of competency that include the requirement for workplace hours.

Under the Education and Care Services National Law (2011) the Australian Children's Education and Care Quality Authority (ACECQA) publishes lists of approved early childhood education and care qualifications and information regarding regulatory requirements here: www.acecqa.gov.au.

Entry requirements

The course will be available for those students who completed year 12 or equivalent. 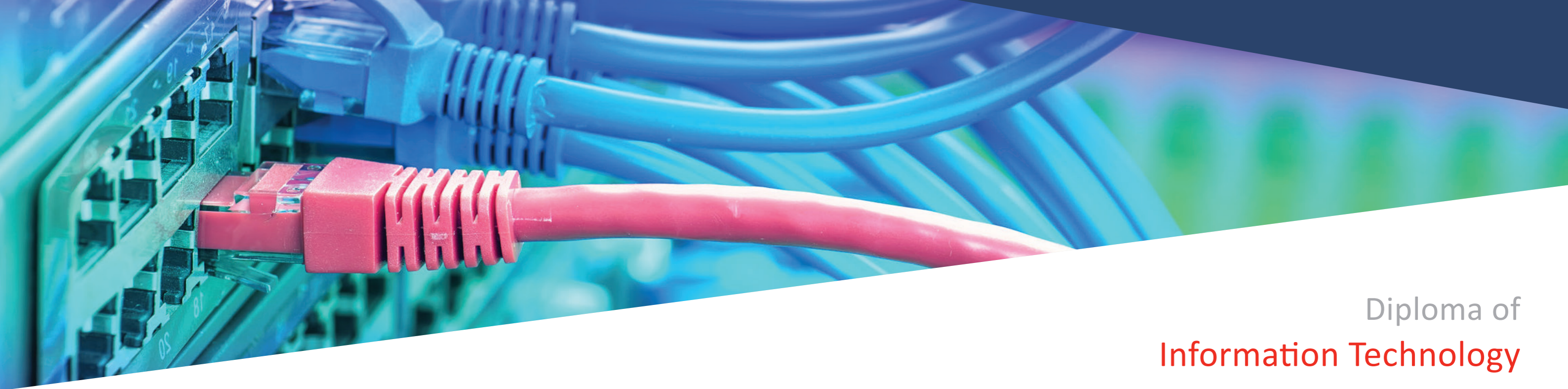

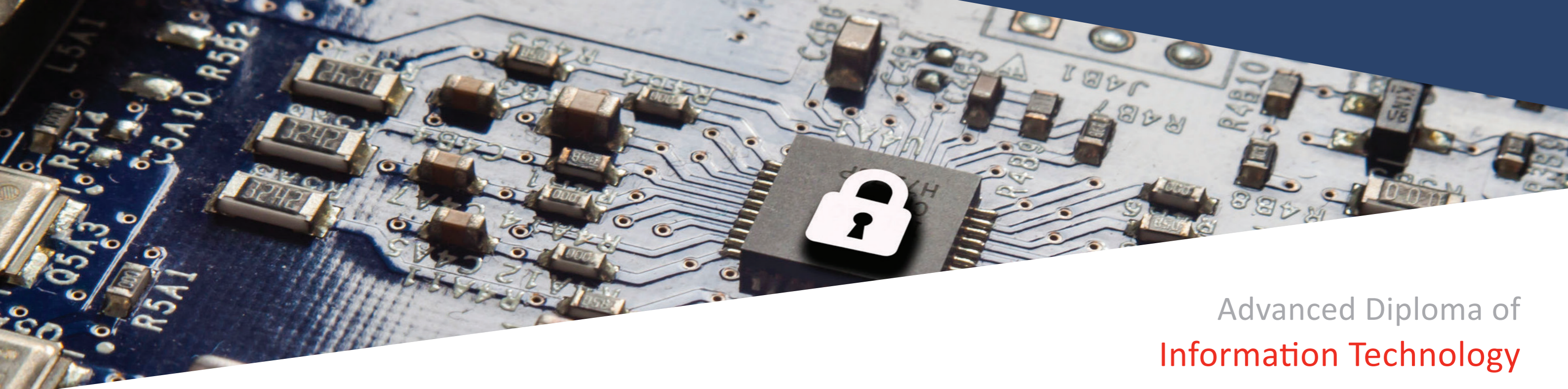

The course will be available for those students who completed year 12 or equivalent. International students require a minimum English level of IELTS 6.0 (with no individual band less than 5.5) If the level of English is insufficient, a suitable course can be organised.

Vocational Outcomes

This qualification provides the skills, knowledge and competencies to deal with relevant real-life situations in the workplace for an individual to function as a Project Contract Manager, Team Leader (Industry Specific), Project Vendor Manager.

Target Group

The target group for this qualification is candidates who require skills in Business and Management area. This may include local and International students.

Course Completion

Students who achieve a 'Competent' result in all required units of study will be awarded the certificate for the qualification. A statement of attainment will be issued for any units in which the student has been assessed as 'Competent.'

Delivery Modes

CIBT uses a blended learning methodology combining classroom-based learning with computer-mediated activities as studies show blended learning improves student's interaction and satisfaction as well as increase learning outcomes. Delivery involves 20 hours per week total tuition with 15 hours/week of classroom-based delivery on campus and for 5 hours/week students would be taking part in computer-mediated activities via online Learning Management System (MOODLE).

Trainers and Assessors

All CIBT trainers/assessors are highly qualified and experienced. They have TAE40116 Certificate IV in Training and Assessment or its equivalent plus suitable industry experience along with the qualification to teach Diploma of Project Management.

Assessments

Each unit will be assessed in at least 2 different ways unless otherwise required by the unit of competency. The assessment will be conducted through a range of assessments including work placement logs, simulation, projects, case studies, short answers, and presentation

Course Structure

The 12 units of competency (8 Core and 4 Electives) are delivered throughout the 50 Weeks (36 weeks delivery and 20 weeks holiday). All units of competency must be completed to receive a Diploma of Project Management qualification.

Pre-requisite: None

Crown Institute of Business and Technology's First Aid course gives participants the skills to respond to a range of emergencies, following Australian Resuscitation Council (ARC) guidelines and national standards.

Key areas include:

- Responding to emergencies – assessing situations, ensuring safety, and seeking help
- Providing first aid – treating asthma, anaphylaxis, bleeding, choking, burns, fractures, shock, and performing CPR
- Using equipment – operating AEDs, EpiPens, bandages, and other tools
- Reporting incidents – communicating with emergency services, completing workplace reports, and maintaining privacy
- Reviewing responses – reflecting on incidents and identifying ways to improve

Participants will build confidence in handling emergencies and learn practical skills for both work and community settings.
